

State of Georgia Military Economic Impact Report

The state of Georgia hosts nine military installations, making military operations one of the most central components of Georgia's economy. Moreover, this makes the Department of Defense one of the largest employers in the state, providing over 150,000 jobs directly, and indirectly employing a third of a million Georgians as of 2019. Additionally, many active-duty personnel retire in Georgia, which is home to nearly 630,000 veterans⁵ engaged local communities and the workforce. Nearly one in ten Georgians are associated with military, which is nearly twice the national average.

As of 2020, Federal Defense Spending in Georgia reached upwards of \$15.8 billion in federal spending¹ in the state. **The current total estimated impact of military operation on Georgia is approximately \$22 billion annually**, which accounts for approximately 2.5% of Georgia's overall GDP^{2,4}, but an *estimated average of 30% of the GDP of each local community in which each installation is situated*.

As of September 2021, Georgia hosts nearly 70,000 active-duty personnel. Approximately 53,000 Army, 9,000 Airforce, 1,000 Marine Corps, 6,000 Navy and 500 Coast Guard service men and women⁶. With an additional 27,000 in reserves and almost 35,000 in military civilians, Georgia hosts the 6th most total military personnel in the country³.
